Blair Woods Sanctuary is a 10-acre tract of woods, prairie, and wetlands in an urban setting of Austin's east side. Our 715-acre Baker Sanctuary is part of the Balcones Canyonlands Preserve, and is dedicated to the protection of the endangered Golden-cheeked Warbler. Travis Audubon's 12-acre Chaetura Canyon Sanctuary in northwest Austin is world-renowned for research and conservation of Chimney Swifts.
